1. RANGE LOCATION: The Ben Avery (Black Canyon) Shooting Range, 25 mi. North of Phoenix, AZ. ½ mile West of I-17 on the Carefree Hwy. (Exit 223).
 2. FACILITIES: A Camping area, with electricity, water & toilet facilities is available, during the matches, for competitors only. Soft drinks are available but bring your own lunch.
 3. RULES: Current NRA High Power Rifle Rules shall apply.
 4. ELIGIBILITY: All competitors must be paid up members of the ASR&PA. (\$25.00 for adults, \$10.00 for juniors). If a competitor does not wish to join the ASR&PA, he/she may pay a \$10.00 match membership fee. **All competitors must show their ASR&PA membership card at the stat office when they are obtaining their squadding or pay the 10.00 match membership fee.**
 5. ADVANCE ENTRIES ARE REQUIRED: All entries must be paid for in advance.
 6. INDIVIDUAL ENTRIES: Make entry in individual events on enclosed Registration & Entry form (include NRA Membership ID#). Entries MUST be accompanied by check money order made payable to ASR&PA, HP Div. Mail to Middleton Tompkins, STE 822, 3120 W Carefree Highway, Phoenix, AZ 85086. Phone: (602) 618-4041. Fees paid by those unable to attend will be refunded upon request, less a \$10.00 service fee, providing cancellation is made prior to 6:00 PM, Monday, 4 Nov. 2024. There will be no refunds for those cancellations after that time. You may also enter online at Desertsharpshooters.com
 7. ENTRIES CLOSE: 6:00 PM Monday 4 Nov. 2024. Entries after this time are considered late entries and may be accepted to fill vacancies on existing relays only. An additional \$20.00 may be charged for late entries.
 8. ENTRY LIMITS: 150 Individual entries.

Military teams must make advance arrangements to pay match fees.

Reminder: Everyone who is not a current paid up member of the ASR&PA must select one of the following options:

a. Those wishing to be a member of the ASR&PA may do so by submitting appropriate fees (\$25.00 for adults; \$10.00 for juniors).

OR

b. Those not wishing to be a member of the ASR&PA must pay a \$10.00 one-time match membership fee.

LATE ENTRY FEE: \$20.00 in addition to appropriate match fee.

CHALLENGE FEE: \$1.00 The challenge fee must be paid at the time the challenge is requested.

10. PRACTICE FIRING: There will be no practice firing before the match.

11. TARGETS: MR-1 & MR-1FC for F-Class

12. TARGET SERVICE: Competitors **will pull** their own targets.

13. EMPTY CHAMBER INDICATOR (ECI): Approved NRA empty chamber indicators are required to be always used except during the preparation time and firing of our relay. Those not having an ECI may purchase one at the stat. office for \$2.00 each.

14. SQUADDING: All matches will be squadded. Squadding tickets for individual matches will be issued at the Stat. Office starting at approx. 7:30 AM Saturday 9 Nov. and Sunday 10 Nov. A competitor who fails to obtain his squadding ticket by 8:30 AM will only be squadded to fill up vacancies. Classification Cards must be shown before squadding tickets will be issued.

15. SCORING: Competitors will score. Any competitor failing to perform his scoring duties may be disqualified. The alternate scoring system will be used for safety reasons.

16. CLASSIFICATION: NRA High Power Classification will be used. Rule 19.6 "Assigned Classification" may be used. Those unclassified or without proof of classification, will be required to compete in the Master class. Please indicate classification on the registration form.

17. DIVISION BY RIFLE: Matches #1, #2, #3, #4, #5, #6, #7, Any/Any Rifle (Division A), Palma Rifle (Division P), Service Rifle (Division S), F-Open (Division O), F-TR, (Division T),

NOTE: Individuals may use a different rifle in each match.

18. CATEGORIES: (Sat, & Sun) Service, (Includes Reserve, and National Guard) and Civilian.

19. AWARDS: Medals will be awarded to 1st, 2nd & 3rd Match aggregate winners in each Division Category award group on Sunday. Monetary award groups must contain a minimum of 5 competitors, or they will be combined with the next appropriate award group per policy. Second, third, fourth place, etc.

SPECIAL INDIVIDUAL AWARDS: In match #9 High Junior will be awarded.

20. CHALLENGE PERIOD: The challenge period ends 1/2 hour after the posting of the match results.

21. RESULTS BULLETINS: Results bulletins will only be mailed to those people requesting them. The match results will be posted on the Desert Sharpshooters web site.

MATCH 4: 600 yds. slow fire prone, unlimited sighters & 20 shots for record, 22 minutes. MR-1 & MR-1FC (F-Class) target.

MATCH 5: 600 yds. slow fire prone, 2 sighters & 20 shots for record, 22 minutes. MR-1 & MR-1FC (F-Class) target.

MATCH 6: 600 yds. slow fire prone, 2 sighters & 20 shots for record, 22 minutes. MR-1 & MR-1FC (F-Class) target.

MATCH 7: Arizona State Midrange Championship: An aggregate of scores fired in matches #1, #2, #3, #4, #5 #6.
